


Siyaru'l-muta'akhkhirin

The History of Latter Days India in the Eighteenth Century

Ghulam Husain Khan Tabataba'i's Siyaru'l-muta'akhkhirin is divided into three unequal parts. The first part traces the history of the Mughal Empire from the death of Aurangzeb in 1707 to the latter part of Muhammad Shah's reign, around 1740. The second part focuses on the history of Bihar and Bengal from the death of the governor Shuja'uddaula in 1739 through the nizamate of Sirajuddaula, who was deposed, and died in 1757. The third part returns to the history of the empire at large, picking it up at 1740 and continuing to 1780. Since Ghulam Husain Khan spent almost his entire life in Bihar and Bengal and had family ties to many of the rulers, he was a first-hand witness to many of the events of which he writes. He was also acquainted with many of the British employees of the East India Company and has insightful observations on the rule (and misrule) of the Company and the part it played in the impoverishment of the region. Of particular interest are Ghulam Husain Khan's digressions on his own life. These rare glimpses into the personal lives of the author and those around him show how precarious one's position was in an age of shifting fortunes as the power and prestige of the Mughal Empire were diminished and lives and livelihoods could depend upon the whim of an autocratic local ruler.

Copious notes identifying persons and places as well as a glossary of non-English terms and genealogical and dynastic charts add to the value of the translation.

WHEELER THACKSTON is a retired academic who taught Persian, Arabic, and other Near Eastern languages for forty years. He has translated Babur's memoirs, three Persian memoirs about Humayun, and Jahangir's memoirs. He has also edited and translated Abu'l-Fazl's *Akbarnama* and many other works.





Gender, Religion and Local History

The Early Deccan

Gender, Religion and Local History: The Early Deccan straddles two areas of research, namely the study of women in a socioreligious context and images of the feminine that emerged as objects of worship. Based on a study of inscriptions, sculptural representations and archaeological and literary sources, the research in this volume is located in different local contexts that focus on gender and ideology in order to discern the dynamics of social change. The seven chapters of the volume address diverse religious spaces—from the folk of the Lajjā Gaurīs to the temple-based Hinduism of the nityasumangali and Chenchu Lakṣmī, from the evolution of orthodox Jaina attitudes to women's access to sallekhanā and to the expanding Buddhist religious milieu in the midst of vibrant mithuna couples. This work demonstrates that ideology in local contexts was always open to adjustments and negotiation, while concomitantly being linked to pan-Indian conceptual foundations.



Agrarian Poverty in Colonial Uttar Pradesh

The Dufferin Inquiry, 1887–1888

It is seldom recognized that Indian nationalism had its beginnings in the belief that India was being increasingly impoverished under British rule. To contest claims about the growing poverty in India, Viceroy Lord Dufferin, in August 1887, decided to institute an inquiry to establish whether 'the greater population of India suffer from a daily insufficiency of food'. But, in effect, the inquiry as organized by the provincial governments and conducted by the district 'Collectors', extended to all material and social aspects of the lives of the rural poor in India. The printed volumes of the inquiry were not made available to the public. Agrarian Poverty in Colonial Uttar Pradesh: The Dufferin Inquiry, 1887–1888 thus brings to the reading public what has practically been a closed book till now.



This is the first book of the New Ecology of Expressive Modes in Early-Modern South India (NEEM Series), edited by David Shulman. *Introspection and Insight* explores the literature, music, and graphic arts of south India between the late fifteenth and early nineteenth centuries, and focuses on their theoretical and philosophical foundations as well as the distinctive features that reveal a newly emergent concept of the individual self and novel models of the mind. This is contextualized as part of a wider civilizational shift throughout the southern regions of India, involving radical changes in taste and sensibility—signifying moments of major cultural innovation. Of these, music was, perhaps, the most eloquent vehicle for personal introspection at this time.


Freedom and Partition

Momentous Events of 14–17 August 1947 in India and Pakistan

Freedom and Partition offers a reconstruction of four momentous days which shaped the lives of millions of people in the Indian subcontinent: 14–17 August 1947. Based on primary archival material, newspaper reports, oral histories and private papers of leaders, it looks at how the outgoing British officials worked with the leaders of the Congress and the Muslim League to plan the ceremonies that would mark the birth of India and Pakistan. In doing so, this book offers a ringside view of events in New Delhi and Karachi. Moving away from official ceremonies, Freedom and Partition uses a 'slice of life' approach to see how ordinary people in cities and towns looked at the approaching moment, capturing the sense of trepidation and insecurity felt by minority communities in Bengal, Punjab, Sindh and across much of north India.



Each essay in India's History, India's Raj: Essays in Historical *Understanding* represents but one of a myriad facets in the story of how Indians themselves participated in the construction not only of the Indian Raj but of Indian history. Due to distortions, omissions, or ideological bias, much of this story remains unbalanced or simply misunderstood. The essays in this volume represent but small signposts pointing down another road. Never before in history has the whole 'continent' of geographic India, surrounded by mountain ranges to the north and oceans to the south, been unified under a single political system. That is—until modern times. The empire of Ashoka, while it reached far south, did not cover the entire region. Neither did that of Akbar. How and why was this so? Within the pages of this volume are essays that, in one way or another, and from one perspective or another, seek to address this central question. Whatever the size or durability of a given political system, and however much rulers from outside India might have had a hand in its development, each political system was mainly the product of Indian manpower, Indian money, and Indian methods.


Rethinking Buddhism

The essays in this volume envision, explore, and challenge some well-established views to investigate Buddhist sources and contemplate alternative theories on origin, development of early Schools, and other fundamentals. On the one hand, there are reassessments and reinterpretations of the established hypotheses; on the other, new voices are raised to re-examine the traditional opinions on narratives of understanding the philosophical and literary approaches. This volume examines real historical contexts and finds whether any kind of contestations occurred in different sects of Buddhism and with other existing religions.



Connected Places is a study in the religious geography of India. It explores ways in which people live in and understand their worlds. In the book, Anne Feldhaus examines a variety of religious ideas, images, and rituals that give people a sense of the coherence and meaning of a particular region. The book focuses on Maharashtra, the Marathi-speaking region of western India that is home to 125 million people. Using rich examples from this state, Feldhaus explores how people in Maharashtra orient themselves to the world, how they connect places to one another, and how they understand themselves in relation to the regions they inhabit. The book draws upon Feldhaus's decades of experience visiting holy places, attending religious festivals, and interacting with story-tellers, pilgrims, and priests, as well as her careful reading of travelogues and religious texts in Sanskrit and Marathi.



Jawaharlal Nehru: A Communicator and Democratic Leader explores multiple facets of Nehru's experiments in communication as a speaker, writer and formulator of policy as a part of the Congress. Simultaneously he discovers within himself a remarkable capacity to convey all this and much more through the written word—articles, dispatches, addresses and, most of all, books.


Many Mahābhāratas*

Many Mahābhāratas is an introduction to the spectacular and long-lived diversity of Mahābhārata literature in South Asia. This diversity begins with the Sanskrit Mahābhārata, an early epic poem that narrates the events of a catastrophic fratricidal war. Along the way, it draws in nearly everything else in Hindu mythology, philosophy, and story literature. The many Mahābhāratas of this book come from the first century to the twenty-first. They are composed in nine different languages— Apabhramsha, Bengali, English, Hindi, Kannada, Malayalam, Sanskrit, Tamil, and Telugu. Early chapters illuminate themes of retelling within the Sanskrit Mahābhārata itself, demonstrating that the story's propensity for regeneration emerges from within. The majority of the book, however, reaches far beyond the Sanskrit epic. Readers dive into classical dramas, premodern vernacular poems, regional performance traditions, commentaries, graphic novels, political essays, novels, and contemporary theater productions-all of them Mahābhāratas.



The Climate of History in a Planetary Age*

For the past decade, historian Dipesh Chakrabarty has been one of the most influential scholars addressing the meaning of climate change. Climate change, he argues, upends long-standing ideas of history, modernity, and globalization. The burden of *The Climate of History in a Planetary Age* is to grapple with what this means and to confront humanities scholars with ideas they have been reluctant to reconsider—from the changed nature of human agency to a new acceptance of universals. Chakrabarty argues that we must see ourselves from two perspectives at once: the planetary and the global. This distinction is central to Chakrabarty's work—the globe is a human-centric construction, while a planetary perspective intentionally decenters the human.



The Asoka Inscriptions

Analysing A Corpus

The Aśoka Inscriptions: Analysing a Corpus attempts a textual and literary analysis of the inscriptions of Aśoka-the oldest in India-and their relationship as a corpus. Unique in both content and format, the inscriptions primarily engage with ideas of good kingship and dhamma rather than with donations made or the celebration of territorial conquests, the usual topics of later inscriptions. They are also characterized by a division that determined their distribution across the realm: the Rock Edict Series (consisting of fourteen edicts) was intended for people living near the borders of Aśoka's realm while the Pillar Edict Series (six in number) was meant for people living at the empire's centre. Meant to be part of a project to commemorate Aśoka, the inscriptions also testify to the existence of an epistolary tradition in the subcontinent, as the texts themselves were selected by later Maurya kings from the letters sent by Aśoka to his representatives across the empire.



Kabir Poems in Transformation

A Fountain of Creativity

Kabir Poems in Transformation: A Fountain of Creativity explores how images of Kabir, in circulation amongst his Hindispeaking followers at the start of the twentieth century, were transformed into versions of Kabir more acceptable to global English-speaking audiences in contemporary times. This work investigates how the creation of an image of Kabir as an ideal Indian mystic poet led to the eclipse of Kabir as the voice of the lower castes and marginalized communities in India. The argument is that rather than seeing an idealized version of his persona through the lens of any particular segment of the audience, Kabir should be studied through the multiplicity of images transmitted amongst diverse communities within India and around the world. This book focuses on the networks of contexts in which these verses were transmitted, and where such a significant transformation took place.



Like the heterogeneity of the idyllic landscape of the Ganga-Brahmaputra valleys, the art historical traditions of the region manifest elements of bewildering diversity and multiplicity in form and media. Based on empirical researches over four decades across eastern and north-eastern India, Ganga-Brahmaputra and Beyond: Exploring Art and Iconography of Eastern and North-Eastern India explores these diverse creative traditions, visualized and successfully strategized by premodern silpins or craftsmen. Spanning a chronological period from the second and first centuries BCE to the early twentieth century CE, the chapters in this volume, grouped under three themes—'Eastern India: A Journey across Time'; 'Revisiting North-East India'; and 'Interrogating Artists' Choice'—investigate newly discovered data and interrogate existing material through new questions.


The Bahmanī Şūfis

Their Spiritual, Intellectual and Sociopolitical Role in Medieval Deccan, AD1300 to 1538

The Bahmanī Ṣūfīs explores the spiritual, intellectual and socio-political role of the Chishtīs, the Junaydīs and the Qādirīs in the Deccan during the fourteenth and fifteenth centuries. Documenting the presence of Junaydī Sufis at Daulatabad, this work challenges a long-held assumption that the Chishtīs were the earliest to have migrated to Daulatabad and helped the Tughluq administration in the consolidation of Islam.

The volume discusses the evolving relationship between the Ṣūfīs and the Bahmanī sultans, examining the transition that took place between the Gulbarga and Bidar phases due to the arrival and settlement of non-*mulki* Ṣūfīs from Iraq and Iran.


Revisiting Sadeq Hedayat's Blind Owl

Writings on a Modern Persian Novel

Revisiting Sadeq Hedayat's Blind Owl: Writings on a Modern Persian Novel is a commemorative volume of thirteen scholarly articles on the Persian novel Buf-e-Kur (Blind Owl) by Sadeq Hedayat (1903-51). Scholars of Persian studies have long endeavoured to bring this complex novel, written in a unique form and structure, into a simple narrative for afficionados of modern Persian fiction. Thus, the present volume is a 'literary manifesto', presenting perspectives on the novel and the writer from historical, cultural, psychoanalytical, cinematic, artistic, translational, and poetic viewpoints. Drawing upon continued Indo-Iranian relations when Burzoe translated the Panchatantra into Pahlavi in 570 AD to when Hedayat wrote his masterpiece during his India sojourn in 1937, the chapters presented here explore a number of topics: from critiques of translations of the novel into three Indian languages (Bengali, Hindi, and Malayalam) to discussions regarding the compatibility of the novel with cinema and the interface of the novel with Hedayat's sketches and paintings.



Pandit Gauri Datt's *Devrani Jethani ki Kahani* is often considered the first novel in Hindi. This story follows the fortunes of an Agarwal merchant family in Meerut, then under colonial rule. Gauri Datt introduces us to a canvas of characters in which the family's two daughters-in-law remain the focus of interest. Following a familiar pattern, only one of them is virtuous, skilled and literate. The novel acknowledges the large extended family's aspirations for social mobility, reform and modernity, while capturing the swiftly transforming everyday and ritual life of merchant communities.


Through the Lens, Brightly


West Asia and the World


Sultanate Ahmadabad and its Monuments

A group of monuments in Ahmadabad constructed under the patronage of the Muzaffarid (Ahmad Shahi) sultanate of Gujarat stand testimony today to the composite heritage of the city. Sultanate Ahmadabad and its Monuments serves as a succinct guide to these representative monuments constructed under a sovereignty that endured for almost two centuries until its annexation into the Mughal Empire under Akbar in 1573. The Ahmad Shahi sultanate architecture merits attention on the grounds of its distinctive constructional as well as ornamental features. The innovative syncretic richness of these structures needs to be considered in light of the historical, cultural, and political exigencies of the Gujarat sultanate that bear upon the formation of this unique regional idiom within the continuum of Indo Islamic architecture. With a concise Introduction to historical, cultural, and architectural currents, this book lays out helpful itineraries for visiting these refined specimens of sultanate architecture in Ahmadabad.



City of Façades: Archaeology, History, and Urbanism in Velha Goa revisits early modern colonial urbanisms through an archaeological project conducted in 2012 at the Portuguese colonial site of Velha Goa, India. Histories written about the city's growth and decline from 1510 to the current day are unavoidably structured by elite, top-down understandings of social processes, owing principally to the limits of the colonial archives themselves. As a result, quotidian material transformations, essential to urban processes, remain largely unconsidered. The archaeological data explored in this volume allows us to reflect on these transformations and how they shaped colonial life, both during and after Portuguese rule.



A crucial feature of her scholarship has been her emphasis on the significance of gender in the reconstruction of India's pasts. She has enriched our understanding of social history through essays and edited volumes examining institutions and processes, including monarchy, urbanism, caste, the household and renunciatory traditions. While her primary source materials have been Sanskrit and Pali texts, she has also integrated insights from epigraphy and archaeology into her work.







Meaningful Rituals

Persian, Arabic and Bengali in the Nūrnāma Tradition of Eastern Bengal

Meaningful Rituals: Persian, Arabic and Bengali in the Nūrnāma Tradition of Eastern Bengal explores a corpus of texts that centre around the creation of the world by God through his prophet Muhammad in his primordial form as a luminous entity. These short accounts, which bear the title Nūrnāma (The Book of Light), played two roles: as conveyers of knowledge regarding basic Islamic beliefs and cosmology, and as ritual texts meant to protect and bring prosperity to those who read and preserved the physical artefact of the book that contained that knowledge. In addition to introductory chapters on Muslim literacy in eastern Bengal and the treatment of light in scholastic and nonscholastic Muslim literature, Meaningful Rituals contains the text and annotated translations of several Persian and Bengali versions of the Nūrnāma, written between the seventeenth and nineteenth centuries. A close study of this tradition in eastern Bengal demonstrates the rural literati's engagement with the Persian and Arabic languages and literacy.



The Lotus and The Lion

Essays on India's Sanskritic and Persianate Worlds

The Lotus and The Lion dwells on Indian history between the eleventh and the eighteenth centuries, when India was the site of the encounter between two great pan-Asian literary traditions, the Sanskrit and the Persian—metaphorically, the lotus and the lion-and the sociocultural and moral worlds they created and sustained. The book's first part explores how these cosmopolitan and prestigious worlds interacted both with each other and with regional cultures. The second part presents five essays dealing with Islam in precolonial India, ranging from the nature of Islamic traditions, to Islamization in Punjab and Bengal, to current debates on understanding Islam in India. The third part offers two essays on the Mughals, the first elaborating different kinds of frontiers in Mughal history, and the second proposing new ways of evaluating the emperors Akbar and 'Alamgir. The fourth part contains four essays on the Deccan, ranging from the Tughluq invasion to the earliest advent of gunpowder technology and of written vernaculars in the region. The book closes with five essays on historical methodology, each one illustrating a different way of engaging with, and of illuminating, India's rich past.







Political Economy of Colonial and Post-Colonial India analyses critical aspects of the political economy of the colonial and the post-colonial period and focuses on the debates on the transition from one to the other. The volume discusses the Great Divergence, where Britain's shooting forward was predicated upon the devastation of the colonial economy, and instruments used for achieving the subjugation of the Indian economy, such as British monetary policy and particularly the Reserve Bank of India.

A major contribution of the book is to study the politics of the two basic contending classes—the capitalist class and the working class as represented by the Left. It is this that determined which class perspective exercised ideological hegemony or influence over the national movement and, consequently, over the postcolonial Indian state.

Pride of place is given to Pāṇini's śabdānuśāsana and its core, the Aṣṭādhyāyī. These essays treat both Pāṇini's theory and methodology and how these are related to the works of other Indian scholars in fields such as etymology (Yāska's Nirukta), early padapāṭhas for Vedic saṃhitās (e.g. Śākalya), prātiśākhyas (e.g. Śaunaka's R̄gvedapratiśākhya), śikṣā, ritual exegesis (mīmāṃsā), and logic (nyāya). Questions of relative chronology are also considered, as well as early Indian treatments of data that reflect historical linguistic developments. Emphasis is placed on philology: close attention to and appreciation of texts and their traditions before going on to a broader theoretical and historical context.



In the backdrop of the Enlightenment impulse, which held that everything can be known, mapped, counted, categorized, and bounded, and the knowledge thus acquired reshaped into useable forms, the British in India created an epistemological state. The Colonial State and Forms of Knowledge: The British in India examines the fields and bodies of knowledge through which this state was created. The colonial state not only produced historical, linguistic, religious, and purportedly scientific accounts of 'the people of India', but also founded organizations such as the Linguistic Survey of India and the Anthropological Survey of India, besides deploying such forms of institutionalizing knowledge as the 'report of the committee of inquiry' in their quest to know and govern India.


Braj Bhūm in Mughal Times

Braj Bhūm in Mughal Times: The State, Peasants and Gosā'ins represents a unique effort at presenting the conditions of life of the ordinary people in a small region of the Mughal Empire from about the accession of Akbar (1556) to the collapse of Mughal power (1739). The study brings out how the Mughal administration functioned on the ground, how peasant communities were organized and religious men conducted their worldly affairs. We are even able to meet some lowly men and women as distinct individuals. Some interesting facts also emerge: the early dates from which Akbar's grants to temples began; the extensive survey of temples in Braj heartland that Akbar ordered in 1598; and, late in Aurangzeb's reign (1704), the official levy of Re.1 per annum on each village in the Braj region to be collected by the Chaitanya—gosā'ins.

Early Indian Religion and Society

Early Indian Religion and Society examines the gradual disappearance of sacrificial liturgy in South Asia in the first millennium BCE, prompting priestly brāhmaṇas to look towards subaltern rituals and clients, particularly sudras. The growth of urbanization intensified social tensions as well as dissent against sectarian authorities, ultimately leading to the breakup of all major religious sects. As a result, the ideology of total devotion (Bhakti) to a supreme personal lord—lauded in the Ramayana, the Mahabharata and the Bhagavad Gita—spread across the subcontinent. The Bhakti movement and the increasingly restrictive caste system prompted lower castes to aspire to a higher social status.



Women and Medical Profession in Colonial Bengal, 1883–1947

The expansionist policy of the colonial power necessitated official involvement with medical education in Bengal from the early nineteenth century. By the mid-nineteenth century, Western medicine permeated various levels of society, thereby making medicine a remunerative profession. A handful of women receiving higher education aspired for a professional career and medicine became their obvious choice, as women patients refused to consult male doctors during pregnancy or childbirth, or for diseases specific to women. Agnes Smedley


The Life and Times of an American Radical

Agnes Smedley's (1894–1950) career as an activist journalist began in the 1910s and 1920s, with a commitment to the Indian Independence movement. Her anti-imperialism was based on the Jeffersonian tradition of the American Revolution. In New York, she was close to the Lion of the Punjab, Lala Lajpat Rai, writing for his publications until his death. In California, she was involved with the Sikh-led Ghadar party of insurrectionists. Her complicated relationship with the European movement leader Virendranath Chattopadhyaya in Berlin in the 1920s is better known. Smedley left Europe for China in 1929 in an effort to reach India through the backdoor. Once in China, she was struck by the poverty and oppression of ordinary people. Her new cause, in addition to anti-imperialism, became the Chinese peasant. For the next two decades she documented their plight in countless publications (including in the Indian press). Herself the product of rural poverty, she identified like few Westerners did with the plight of peasants, Chinese or Indian, and wrote biographies of Chinese peasant leaders such as Zhu De.

Today, inside and outside of Asia, Smedley is recognized as a feminist icon and one of the most important chroniclers of the Chinese Revolution. Her story is told here for the first time in an Indian edition, including her deep involvement with the Indian Independence movement much before Gandhi appeared on the scene.

JANICE R. MACKINNON (1943–99) was a poet and businesswoman who sold antique Chinese furniture. Historical geography in India, so far, had mainly meant the drawing of boundaries of different states that have emerged and then disappeared over time. This is certainly an important aspect which needs attention, and some of Zahoor Ali Khan's articles in Studies in Indian Historical Geography: From Ancient Sarasvati to the Railway Age deal directly with issues of this nature. But historical geography has a much wider compass, ranging from alterations in river courses to territorial variations in cultural features such as religion and language use or economic phenomena. The author has used cartographic instruments to test existing hypotheses such as the common belief relating to the river Sarasvati or to find answers to questions relating to regional alterations in prices and wages as a result of the construction of the railways. Zahoor Ali Khan provides answers to such queries through maps prepared after an astonishing amount of labour, which the places shown in the maps may not fully indicate.

Kūṭiyāṭṭam, the only surviving live Sanskrit theatre in the world, was defined by UNESCO as 'a masterpiece of the oral and intangible heritage of humanity'. 



Beyond the Metros: Anglo-Indians in India's Smaller Towns and Cities focuses on Anglo-Indians residing in a number of small towns and cities, away from the metropolitan centres of modern India, such as Kolkata, Mumbai, Delhi and Chennai. It provides a socio-historical account of what it means to be an Anglo-Indian in cultural and materially varied environments, highlighting the impact on the formation of identities. The towns and cities can be grouped into three categories: railway towns such as Kharagpur, Asansol, Jhansi, Jabalpur and Secunderabad; the hill stations of Ranchi and Dehradun; and the port cities of Cochin, Pondicherry and Goa.



Islamic and Cultural Foundations of *Kashmiriyat*

In this collection of essays, the late Professor Mohammad Ishaq Khan (1946–2013) caps a lifetime of research into the history of Kashmir, especially of its cultural heritage. These essays are a broad selection from years of scholarship and give a clear view of Professor Khan's contribution to the field. Their main theme is *Kashmiriyat*, the essence of Kashmiri culture that can be traced through history. Professor Khan forcefully argues that Kashmiri Islam is 'neither syncretism nor synthesis'. In other words, Kashmiri culture should not be understood as a watered-down version of a 'pure' Islam, but rather the result of a cultural transformation in no way at odds with Islam as a religion. Professor Khan traces Kashmir's history as an outward looking and culturally self-assured society, tied closely to the rest of the Indian subcontinent, but maintaining unique traditions available to both Muslims and non-Muslims.
